01. Fixation of subscription to become a LM of BMNOBF

Discussion: The Sub-Committee discussed regarding fixation of subscription to become a Life Member of **BMNOBF**.

Decision: (a). Who wishes to become Member within December 31, 2023.

The Subscription is fixed @ BDT30, 000.00 for all aged group

(b) The Subscription is divided into 2 aged groups from January 01, 2024:

Group A: 20years to 40 years BDT30, 000.00

Group B: 40years+ to 60 years BDT40, 000.00

Note: *i. Non COC holders/New entry may arrange payment in installment within 18 Months with a initial payment of BDT10, 000.00. No benefit(s) till full payment is done.*



02. Eligibility to become a LM of BMNOBF

Discussion: The Sub-Committee discussed the eligibility for Membership of **BMNOBF**.

Decision: *Any Bangladeshi Seafarers having CDC/SID/CoC are eligible for becoming a LM of **BMNOBF**. In addition He/She must be a member of **BMMOA** with updated payment of all dues and subscription (s)*

03. Beneficiary/ Beneficiaries of the LM of BMNOBF

Discussion: The Sub-Committee discussed regarding Beneficiary/ Beneficiaries of the Life Member of **BMNOBF**.

Decision: The Beneficiary/ Beneficiaries of the Life Member are defined into 2 (Two) criteria;
(a) *Next of Kin: Husband or Wife and Children (If married or having children);*
(b) *Next of Kin: Father or Mother (If unmarried or divorced);*

04. Eligibility/ Qualifications criteria to avail benefits/get support during urgent and actual need approved by the advisory board / EC Committee.

Discussion: Discussed about the preparation SOP, *On Criteria's for which fund to be provided, and approx amount for each criteria with the authority to fund committee for final decision*

Decision: *Financial benefits only applicable after one year of full payment of Subscription with the approval of Sub and Advisory committee laid down in constitution/SOP/MOU/Agreement A detail SOP to be prepared in light with the present constitution*

05. Age bar to become LM of BMNOBF

Discussion: The Sub-Committee discussed regarding age barrier to become a Life Member of **BMNOBF**.

Decision: *The age barrier is 60 years for becoming a Life Member of **BMNOBF**.*

06. Amendment of constitution & preparing of SOP.

Discussion: The Sub-Committee discussed regarding the subject in details.

Decision: *A draft SOP will be submitted by Engr. Mahabubur Rahman, Vice President, **BMMOA** on May 27, 2023.*

Next meeting for SOP discussion on June 10, 2023.

The present constitution may also be amendment as necessary.

The SOP and constitution may be reviewed after every 3-5 years.
